

**INFORMATION CLAUSE FOR PERSONS PARTICIPATING IN THE
EXCLUSIVE SUPPLY CHAIN EVENT: UNLOCKING BUSINESS OPPORTUNITIES WITH ARAMCO**

Pursuant to Article 13 and Article 14 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as “GDPR”), we hereby inform you of the following:

1. The Administrator of your Personal Data is the Chamber of Commerce and Industry in Katowice, located at ul. Opolska 15, 40-084 Katowice, registered in the Register of Entrepreneurs and the Register of Associations, Other Social and Professional Organizations, Foundations, and Independent Public Healthcare Institutions maintained by the District Court for Katowice-Wschód in Katowice, 8th Commercial Division, of the National Court Register under KRS number: 0000163418, NIP: 634-10-06-202, REGON 003445317 (hereinafter: the **ADP**);
2. Personal data will be processed for the purpose of:
 - a) carrying out the Event by the ADP (based on Article 6(1)(b) of the GDPR) — for the duration of the Event, and after its completion for the period of limitation of claims arising from the contract concluded with you;
 - b) fulfilling the ADP’s obligations arising from generally applicable laws, in particular civil, tax, or accounting law (based on Article 6(1)© of the GDPR) — for the period specified in those laws (generally 5 years from the end of the year in which the event related to the data collection occurred);
 - c) pursuing the legitimate interest of the ADP (Article 6(1)(f) of the GDPR), consisting of:
 - conducting correspondence, including after the cooperation ends,
 - pursuing claims or defending against claims,
 - for as long as this interest persists, but no longer than 3 years after the end of cooperation.
3. Data may also be processed by the ADP on a broader scale based on consent (Article 6(1)(a) of the GDPR). In such a case, the data subject has the right to withdraw consent at any time — without affecting the lawfulness of processing based on consent before its withdrawal. Data will be processed for the period specified in the consent (or until the withdrawal of consent, whichever occurs first).
4. Providing data is always voluntary, but failure to provide it may prevent the ADP from conducting the Event.
5. Your personal data may be disclosed to third parties only if permitted by law — to other administrators or processors. Recipients may include in particular: infrastructure administrators (including hosting providers), co-organizers, subcontractors, persons providing services related to the execution or improvement of the service provision process, as well as advisors and auditors.
6. The Administrator does not transfer your personal data to third countries (outside the European Economic Area).
7. Personal data will not be the basis for automated decision-making, including profiling, by the Administrator.

8. You have the right to request from the Administrator access to your personal data, their rectification, deletion, or restriction of processing, as well as data portability.
9. Additionally, you have the right to object to further processing of your data — for reasons related to your particular situation — regarding processing based on Article 6(1)(f) of the GDPR.
10. If processing is carried out unlawfully, you have the right to lodge a complaint with the supervisory authority — the President of the Personal Data Protection Office (PUODO). Contact details for PUODO are available especially on the website <https://uodo.gov.pl/pl/p/kontakt>.
