

**PRIVACY NOTICE AND CONSENT FORM**  
Exclusive Supply Chain Event:

Aramco Overseas Company B.V. (hereinafter “Aramco”), wholly owned subsidiary of the Saudi Arabian Oil Company (“**Saudi Aramco**”) in Saudi Arabia follows strict corporate guidelines to protect the personal data of its event invitees and attendees to ensure compliance with applicable local privacy and data protection laws and regulations, including the General Data Protection Regulation (GDPR).

Please take a moment to review this Privacy Notice which is a supplemental notice to the AOC Privacy Notice for Suppliers and Consent Form. Aramco informs you below on the types of personal data collected, processed and retained, and the purposes of this processing of such personal data in connection with your attendance to the Exclusive Supply Chain Event: Unlocking Business Opportunities with Aramco at the Courtyard by Marriott Katowice City Centre on April 21, 2026 (“**Event**”).

**Personal Data collected and used by Aramco**

The information collected and used by Aramco could include the following categories of personal data:

- 1) First and last Name;
- 2) Contact information i.e. addresses, phone numbers, email addresses;
- 3) Company you work for and your job title and country of residence;
- 4) Industry you work in;
- 5) Photographs, video footage, audio recordings, created during the Event;
- 6) Other information you voluntarily provide to us; and
- 7) Other information needed or permitted under applicable law.

**The Purposes for Processing Your Data**

The personal data that you provide Aramco is only collected and used in connection with your invitation for and attendance to the Event. We collect and use your personal data for the following purposes:

- 1) *Sending invitations and managing registration forms.* We use your first name, last name, email address, phone number, the company you work for, and your job title to send you invitations for the Event and to manage the registration forms with the support from our service providers - Chamber of Commerce and Industry in Katowice.
- 2) *Marketing purposes.* During the Event, photographs, video and voice recordings are taken, for the purpose of producing, publishing and distributing publicity, corporate communications and promotional content for Aramco and Chamber of Commerce and Industry in Katowice, included but not limited to (i) Digital and printed publications; (ii) corporate websites and intranet; (iii) social media channels, (iv) marketing or promotional campaigns; (v) editorial articles and interviews, (vi) press and media engagement; (vi) internal or external communication materials.

Personal Data may appear in online and print formats, including possible publication by media outlets.

**Legal bases for the use of personal data**

- *Legitimate interest.* We rely on our legitimate commercial interest with respect to the use of personal data as described above in order to select and invite you to the Event.

- **Consent.** The legal basis for processing your photographs, video footage, audio recordings created during the Event is consent. You may withdraw consent at all times by contacting us via [PublicRelations@aramcoeuropa.com](mailto:PublicRelations@aramcoeuropa.com).

Withdrawal of consent shall not affect the lawfulness of prior processing.

If materials have already been published or distributed, it may not be possible to withdraw them from circulation; however, Aramco will delete your Personal Data from its repositories and will make all reasonable efforts to cease further use.

## **Your Rights**

Under applicable law, you have rights regarding your Personal Data. You may have the right to, as applicable, under applicable local privacy and data protection laws:

- Withdraw consent;
- Access your Personal Data;
- Rectify your Personal Data (add to or update or correct some of your personal data);
- Request the deletion of your Personal Data;
- Restrict the processing of your Personal Data;
- Object to the processing of your Personal Data;
- Portability of your Personal Data;

## **Handling of Your Personal Data**

Access to Personal Data is restricted to individuals within Aramco and its affiliates, including the Saudi Arabian Oil Company (“Saudi Aramco”) and approved service providers, including but not limited to Chamber of Commerce and Industry in Katowice who require access to perform functions related to the Event.

Service providers (e.g., production companies, editors, photographers, designers, media agencies) may receive limited access as necessary. Aramco has appropriate agreements in place to safeguard your data.

## **International Transfers**

Depending on the nature of the Event and the location where materials are published (including websites and social media), your Personal Data may be visible outside the European Union (“EU”), where different data protection standards may apply. Where required, Aramco has Data Transfer Agreements or equivalent safeguards in place to ensure lawful transfers.

## **Retention**

Aramco shall retain your Personal Data, including those not used for the purpose referred to above in its repository in accordance with our internal policies and applicable law for a period of six months or for a shorter period when consent is withdrawn before that time. After the applicable period, the Personal Data will be securely deleted or anonymized.

You may request earlier deletion at any time using the contact details above.

## **Intellectual Property/Copyright**

All intellectual property rights in the photographs, video recordings, audio recordings, interviews and other created content will belong to Aramco. Aramco may use such content for the purposes described in this Privacy Notice.
